Auditor/Audit Evaluator – Financial Reporting

The United States Postal Service Office of Inspector General (OIG) is seeking a highly qualified candidate to fill an Auditor/Audit Evaluator position within the OIG functional area of Financial Reporting located in Arlington, VA. The directorate conducts audits and reviews in support of the Board of Governors' independent public accountant's overall opinion of Postal Service financial reporting. The successful candidate will conduct audits and reviews focusing on financial and/or information systems relative to financial reporting. The OIG mission is to provide reports to Postal Service Executives, Governors and Congress to help the Postal Service maximize revenues (approximately \$70 billion annually), minimize costs, and prevent and detect fraud, waste, abuse and mismanagement.

ELIGIBILITY REQUIREMENTS

- Bachelor's degree from an accredited college or university in accounting or in a business related field that included or was supplemented by 24 semester hours in accounting; **OR** Bachelor's degree from an accredited college or university

EVALUATION FACTORS

Your resume cannot exceed five pages, and **must** reflect that you have experience, knowledge or skills in each of the following Evaluation Factors listed below.

- Knowledge of government auditing standards, generally accepted accounting and auditing principles; auditing concepts, methodologies, procedures, analytical techniques, and internal control reviews
- Skills in analyzing various information/problems and presenting findings and recommendations
- Ability to communicate both orally and in writing
- Ability to apply effective project management and work on a team, whether as a team member or leader, to accomplish project objectives and goals

DESIRED QUALIFICATIONS

- Professional Certification(s) and/or an advance degree(s)
- Experience in performing complex multi-site (nationwide) audits
- Work experience in financial auditing or accounting

ADDITIONAL REQUIREMENTS

- Ability to pass a physical examination, drug screening, and a background investigation
- Ability to obtain/ maintain a government-issued credit card
- May require up to 50 percent travel

Veterans must submit a copy of a letter dated within the last 12 months from the Department of Veterans Affairs or the Department of Defense certifying receipt of compensation for a service-connected disability of 30 percent or more
