**Summary**

The USPS OIG is seeking a highly qualified applicant to fill our Geographic Information Systems Specialist (GIS) position in the Research and Insights Solution Center (RISC) located in Arlington, Virginia. Bring your skills and voice to our team!

**Duties**

The RISC Chief Data Office conducts innovative research and analysis on Postal Service operations in support of auditors and agents. Our team develops analytical products that facilitate lead generation and provide critical insights for audit and investigative activities. Our methods frequently involve statistics or complex, multi-step analyses of large and disparate data systems.

The successful candidate will work extensively in a collaborative, team environment that involves audit and investigative clients, subject matter experts, project team leads, and executive stakeholders. RISC's work has a strong customer focus, requiring effective written and verbal communication skills to understand the needs of the client and to give structure to complex problems with undefined or ambiguous solutions. Our team requires candidates with strong technical skills to develop data engineering solutions to provide data to the data analysts and data scientists to support their analyses. The candidate will exhibit effective communication skills which include the documentation of analytical methodologies and briefings and presentations of technical content to executive leadership, stakeholders, peers, and other audiences.

Candidates will be evaluated on the skills that they possess that are directly related to the duties of the position and the experience, education and training that indicate the applicant's ability to acquire the particular knowledge and skills needed to perform the duties of the position. Only those candidates who meet all qualification and eligibility requirements and who submit the required information by 11:59 PM EST on 6/27/2025 will be considered.

The USPS OIG uses a Pay Banding system, which is equivalent to the Federal GS scale. Grade and salary determinations will be made based upon a candidate's education and professional experience.

This position is being advertised at the Specialist Band level, equivalent to a GS-14. The salary range for this position is \$142,488.00 - \$185,234.00. The salary figures include locality pay.

## **Responsibilities**

The successful candidate will utilize advanced techniques and technology to ingest, manipulate, analyze, and render geographic and analytical insights from data, automate and increase the efficiency of GIS processing, and document and build enterprise solutions. The candidate will also plan and assist in conducting various analysis, preparing and presenting executive presentations, and organizing stakeholder events and activities related to audit and investigations work.

Please note that the duties and responsibilities associated with this position may vary based upon the agency's needs at the time of hire. The following description of major duties and responsibilities is only intended to give applicants a general overview of the expectations.

- Act as the technical and strategic lead for the OIG's GIS program by developing, maintaining, and executing the agency's GIS strategy and roadmap.
- Provide advice on machine characteristics that affect software systems, such as storage capacity, processing speed, and input/output requirements.
- Utilize ArcGIS systems (ArcGIS Desktop, Pro, AGOL) to complete complex geospatial analyses and produce visual outputs involving millions of records.
- Use scripting languages such as JavaScript, Python, and SQL to write and maintain scripts to manipulate data and automate complex workflows, as well as join various databases for analytical processing.
- Present information and results to a variety of clients, host training sessions, and formal presentations.
- Troubleshoot problems and provide customer support for software operating system and application issues.
- Work closely with IT and GIS staff to maintain and improve operations.
- Execute maintenance and upgrades of enterprise-wide ESRI ArcGIS systems and/or applications software needed for GIS analysis.
- Performs complex geographic analyses and uses data modeling and machine learning techniques to identify interrelationships among data.
- Design, develop, deploy, and maintain solutions and apps to connect ArcGIS to other software platforms.

- Write and update technical documentation such as user manuals, system documentation, and training materials.
- Prepare comprehensive test plans and conduct tests.
- Work independently and within teams to complete varied analytical and GIS-related projects and tasks.

## **Requirements**

- Demonstrated experience of programmatic development of GIS solutions to include Python, JavaScript, SQL scripting.
- Demonstrated quantitative and qualitative skills to determine systemic or procedural problems and develop findings and recommendations.
- Demonstrated experience developing and executing a GIS strategy and roadmap.
- Ability to express and present ideas clearly and concisely, both orally and in writing.
