Duties

The successful candidate will be responsible for leading research projects; the development of analytical techniques for studies and special analyses of major issues impacting the Postal Service; and writing, editing, and planning major reports.

Our team researches economic, business, policy, and technological trends affecting the U.S. Postal Service. Our body of work spans a wide variety of topics, from economic analysis of the postal market to sustainable processing and transportation strategies, to labor and workforce matters. - Contributes to the creation of diverse content formats, beyond traditional white papers, to present research findings and reach a wider audience, such as digital stories, podcasts and internal/external events (e.g., webinars and in-person expert panels).
- Presents research findings in public forums, conducts meetings with internal leadership, the Postal Service and other external stakeholders to discuss project plans and outcomes.
- Provides strategic insights to enhance the unit's research portfolio while serving as an internal advisor to support and guide other teams.
